Rome Police Department Monthly Report April 2015

Meetings/Training Attended

During the month of April I attended Town Board, and PFC meetings. Officer Swiedarke is attending Drug Recognition Expert Training in Milwaukee. This training is funded through grant money including the lodging and meal expenses. Officers attended active shooter training with the Adams County Sheriff's Office. These training costs were also reimbursed by the State.

Calls for Service, Citations, and Written Warnings

In April officers handled 91 calls for service, and issued 44 citations and 9 written warnings.

Department Activities/Announcements

The 2015 Dodge Charger has been put in service replacing the 2009 Dodge Charger which was sold. I am currently installing new radios in the remaining squad cars. As the radios are installed the old radios are being redeployed in the Fire Department, Highway Department, and patrol boats.

Regulatory buoys have been placed in the lakes for the 2015 boating season. We have two boat patrol officers hired to patrol the lakes for the 2015 season. The new patrol boat has arrived and is currently being equipped for patrol. If staffing allows I plan on having both boats on the water on our busiest weekends.

Staffing is down to three full-time officers after receiving Officer Eckstein's resignation in April. Part-time officers and I are filling the vacant shifts in the schedule.

An oil pressure sensor and the A/C on the 2013 Charger were repaired under warranty at no cost during April. No other repairs were made to the fleet during the month of April.
