## Rome Police Department Monthly Report October 2014

### **Meetings/Training Attended**

During the month of October I attended PFC, and Town Board meetings. Officer Swiedarke attended the Coordinated Community Response Team meeting, and conducted a Naloxone training with all of the Patrol Officers.

### **Calls for Service, Citations, and Written Warnings**

During the month of October officers handled 95 calls for service, issued 29 citations and 2 written warnings.

### **Department Activities/Announcements**

Officers recently completed training on how to properly administer Naloxone in conjunction with the Rome Fire Department and Rome First responders. The medication is capable of reversing the often-fatal effects of opioid overdoses. Fire department personnel and police officers are now carrying Naloxone kits (brand name Narcan) with them while on duty. The kits, which cost around \$30 each, are being carried in fire vehicles and marked police vehicles.

With the recent taste of winter I would like to remind residents that it is time to watch the conditions of the road carefully while driving and be aware of snow removal equipment on the roadways.

State law requires the operator of any motor vehicle that is not a snowplow to remain at least 200 feet behind the snowplow on roads with a speed limit of more than 35 MPH, and 75 feet behind on roadways posted at 35 MPH or less. The law also states if a snow plow is stopped at an intersection the operator of any vehicle shall remain a minimum of 20 feet behind the snowplow (out of the intersection) and shall remain stopped until the snowplow resumes motion.
