## Rome Police Department Monthly Report April 2017

### **Meetings/Training Attended**

During the month of April I attended a PFC meeting, and Town Board meetings.

### **Calls for Service, Citations, and Written Warnings**

In April officers handled 88 calls for service, and issued 6 citations and 5 written warnings.

### **Department Activities/Announcements**

We are also in the process of hiring three part-time officers for our boat patrol. We should have these positions filled within the next 2 weeks so they are ready by Memorial Day Weekend. The patrol will then work weekends and other busy days as needed through Labor Day patrolling the lakes.

I would like to continue to remind residents the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

One of the Officers involved in a motor vehicle crash, responding to an emergency call for service, remains off duty due to injuries received in the crash. Shifts continue to be filled by utilizing part time Officers. I anticipate one of the injured Officers, currently on light duty, being cleared for full duty by the end of May.

In March the P.D. was awarded a \$ 4,000 traffic equipment grant which will be used to replace aging radar units that are starting to have increased maintenance costs. I am waiting for state confirmation of the funds so the equipment can be ordered.

In the next month I hope to place the regulatory buoys for the 2017 boating season.

Routine maintenance was done to the fleet during April.
