## Rome Police Department Monthly Report August 2017

### Meetings/Training Attended

During the month of August I attended Town Board, Drug Endangered Children, and PFC meetings. Officer Upton became certified in Emergency Vehicle Operation Instruction and a Less Lethal Instructor.

### Calls for Service, Citations, and Written Warnings

In August officers responded to 95 calls for service, and issued 32 citations and 17 written warnings. The Boat Patrol logged 100 hours of patrol and issued 8 citations, and conducted several boating compliance checks.

### Department Activities/Announcements

The Department still has one officer off duty as a result of an on a duty related injury. The officer is not expected to return to duty in the near future. Part time officers continue to be used to fill open shifts in the schedule.

I would like to thank the Boat Patrol Officers for the work they have provided on our lakes this summer. As I write this report the patrol is on the lakes for the last shift of 2017, and as of this time we have had no reported injuries as a result of boating incidents this year.

I am in the process of completing the hiring process to replace part time officers that have left for full time employment. These officers are important for ensuring the overtime rate remains low in the police department.

The 2010 Dodge Charger is currently in the Town Hall parking lot out for sealed bids the bids are due at 4:00pm on September 21, 2017. The equipment will be transferred to a 2017 Ford Explorer in the next month.

Routine maintenance was done to the fleet in August.
