## Rome Police Department Monthly Report February 2017

### **Meetings/Training Attended**

During the month of February I attended a PFC meeting, and Town Board meetings.

### **Calls for Service, Citations, and Written Warnings**

In February officers handled 65 calls for service, and issued 50 citations and 28 written warnings.

### **Department Activities/Announcements**

On February 27, 2017, two of our Officers were involved in a motor vehicle crash responding to an emergency call for service. Both Officers remain off duty due to injuries received in the crash. I wish them a speedy recovery.

As a result of the crash two Department vehicles have been considered a total loss by our insurance carrier. One was a 2016 Ford Explorer, the other is was a 2012 Dodge Charger. I have removed all of the salvageable equipment (emergency lights and such) and tested it to ensure it is working from both of these vehicles. . I am still working with the insurance carrier to settle the claim and get replacement vehicles lined up.

Currently I have been able to fill shifts that are open by utilizing part time Officers and myself which is a great saving to the Town over paying overtime and having full time staff fill the shifts. I anticipate the injured Officers being cleared for duty by the end of May.

I am still waiting to take delivery of a marked 2017 Ford Explorer it was finished at the plant on February 15 and is currently at Ford's modification facility. I hope it will be delivered in the next few weeks so it can be put into service.

I will be continuing to work on replacing the squads and damaged equipment in the upcoming month and hope to equip the 2017 squad and get it into service.

Routine maintenance was done to the fleet during February.
