### Meetings/Training Attended

During the month of November I attended a North Central Chiefs of Police Association meeting in Waupaca, an Attorney General Round Table in Adams, PFC and Town Board meetings. Officer Upton attended a Coordinated Community Response Team meeting. Officers completed State mandated firearms qualification and rifle training with the Adams Police Department.

### Calls for Service, Citations, and Written Warnings

### Department Activities/Announcements

The 2017 Squad up fit was completed and the squad has been placed in service. The 2010 Charger bid was accepted by the board and the vehicle was sold.

The police department participated in the fire department open house and will be participating in the children's Halloween party at the town hall.

Applications continue to come in for the police clerk/ municipal court clerk position. Staff will be screening the applicants and moving forward with interviews.

I have been working with the Adams County Sheriff to renew our access agreement we have with them for access to our records which are housed on their server.

One officer remains off duty due to a work related injury. Part time Officer Joe LeBreck has submitted a letter of resignation his last day will be November 9, 2017. Officer LeBreck was also full time with the Sheriff's Office he was in charge of social media in both Departments. He has been hired by the Oconto County Sheriff's Office which is close to where he grew up. I would like to thank Officer LeBreck for his service to the town and wish him the best of luck in his new career.

Regulatory buoys have been removed from the lakes, and the boat patrol final report is being prepared.
