Meetings/Training Attended

During the months of September I attended an Adams County Crisis Response, PFC, and Town Board meetings. Officers Stashek, Upton and I attended in-service training in Green Lake County. The training was sponsored by the State of Wisconsin Training and Standards; it was a joint training with law enforcement and prosecutors. Sgt. Wilson completed training and will be certified by the State as a vehicle contacts instructor.

Calls for Service, Citations, and Written Warnings

During the month of September officers handled 107 calls for service, issued 34 citations and 2 written warnings. The Boat Patrol logged 48 hours of patrol in September.

Department Activities/Announcements

This is the time of year we would like to remind our residents that if they are planning to leave their home for an extended period of time please stop by the Town Hall or Police Department to provide us with your contact information should there be an emergency at your property. A vacant home form can be picked up at the Rome Town Hall or can also be found under police department forms tab on our webpage.

The boat patrol has completed their duties for the 2017 boating season. We are now working to complete the final boat patrol enforcement totals and submitting those figures to the DNR so we can be reimbursed a portion of our boat patrol expenditures. The regulatory buoys will be removed from the Lakes for the winter in early October.

Routine maintenance was done to the fleet in September. The patrol boats will be winterized in October.
