Rome Police Department Monthly Report February 2018

Meetings/Training Attended

During the month of February I attended the Town Board meeting. Officer Stashek attended the Adams County Traffic Safety meeting. Officer Upton completed Detective School sponsored by the Milwaukee Police Department. Officer Upton and I attended a table top dam failure exercise training at the Town Hall. Sgt. Wilson, Officer Stashek, and I completed State mandated Emergency Medical Responder Refresher Training.

Calls for Service, Citations, and Written Warnings

Officers handled 78 calls for service, and issued 44 citations and 9 written warnings.

Department Activities/Announcements

The police department still has one Officer off as a result of a February 2017 on duty motor vehicle crash. Officer Cory Valiquette is continuing in the field training program and will be helping fill the open shift slot at the conclusion of his field training in March.

We took delivery of an All-Terrain Vehicle in February; the unit will be used to patrol ATV trails and routes, respond to emergencies at Dyracuse Park by the police departments. The unit will also be available for use by Dyracuse, Fire, and Highway Departments.

The ATV will be up fitted in March and should be ready for the opening of Dyracuse and the ATV trail system. We will carry medical gear to include a Defibrillator on this unit along with gear for ATV patrol duties.
