## Rome Police Department Monthly Report May 2018

### Meetings/Training Attended

During the month of May I attended Adams County Crisis Response Community, Police and Fire Commission, and Town Board meetings. Officer Valiquette and Anderson continue to attend Emergency Medical Responder (EMR) training and will be certified as EMRs and should be licensed at the end of June. Sergeant Wilson attended Internet Crimes against Children (ICAC) training in Appleton, and also some online ICAC training courses.

### Calls for Service, Citations, and Written Warnings

Officers handled 136 calls for service, and issued 61 citations and 20 written warnings. The Boat Patrol logged 26.5 hours of patrol issuing 5 citations and 1 written warning.

### Department Activities/Announcements

We are finishing up with hiring of seasonal recreational officers. The patrols are now scheduled through the rest of the summer months. The patrols will continue to be out during high traffic boating and ATV days. I would encourage boaters and ATV operators to read the latest Handbook of Wisconsin Boating Laws, or Wisconsin ATV Laws prior to taking to the water or trails.

Again I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

In addition I would remind residents and visitors that the Town of Rome regulates noise and during the summer months we see a rise in complaints from neighbors. With windows open loud noise from music, parties and such travels into neighboring homes. Please keep your neighbors in mind when having your outdoor celebrations. Rome limits noise to 80 decibels during the hours of 7am until 10pm and 55 decibels 10pm until 7am. After 10 pm 55 decibels can be compared to a quiet restaurant inside. So use your quiet voices after 10 pm showing consideration for those neighbors that may be sleeping.

Routine maintenance was done to the fleet in May.
