Meetings/Training Attended

During the month of October I attended Town Board, and PFC meetings. Officers Kirsenlohr, Winker, and Valiquette attended Crisis Intervention Team Training, and State Homicide Investigator's case study. Officers Winker and Upton attended Rabies Control Training.

Calls for Service, Citations, and Written Warnings

In October officers handled 106 calls for service. Officers issued 34 citations and 17 written warnings.

Department Activities/Announcements

I received notice from the Wisconsin Department of Transportation that the Town of Rome Police Department was selected for a \$ 4,000 equipment grant. We were eligible for the grant for participating in DOT enforcement campaigns Click It Or Ticket, Drive Sober Or Get Pulled Over and others held throughout the year. We have to wait to use the funds until it is put into the State grant system.

I would like to remind residents to fill out a vacant home form before leaving for the winter. The form is available at the Town Hall or on the Rome PD web page. This will ensure we can contact you should an issue arise with your property over the winter months.

The Department still has one officer off duty as a result of an on duty related injury. The officer is not expected to return to duty in the near future.

Routine maintenance was done to the fleet in October.
