Meetings/Training Attended

During the month of September I attended Town Board, and PFC meetings. Officer Upton attended Coordinated Community Response Team, and Crisis Response Community meetings. Officer Stashek, Upton and I attended the law enforcement symposium in Green Lake.

Calls for Service, Citations, and Written Warnings

In September officers handled 125 calls for service. Officers issued 38 citations and 15 written warnings. The Boat Patrol logged 13 hours of patrol and issued 1 citation, and conducted several boating compliance checks.

Department Activities/Announcements

Boat patrol concluded in September and the final numbers are being calculated for the season. Regulatory buoys have been removed from the lakes for the winter.

I would like to remind residents to fill out a vacant home form before leaving for the winter. The form is available at the Town Hall or on the Rome PD web page. This will ensure we can contact should an issue arise with your property over the winter months.

The Department still has one officer off duty as a result of an on duty related injury. The officer is not expected to return to duty in the near future.

Routine maintenance was done to the fleet in September.
