

CHAPTER 8

MOTOR VEHICLES AND TRAFFIC

8.01 TRAFFIC AND PARKING:

(1) STATE TRAFFIC LAWS AND ADMINISTRATIVE CODES ADOPTED:

(a) Statutes Adopted: Except as otherwise specifically provided in this Chapter, the statutory provisions in Chapters 86 and 340 to 349 of the Wisconsin Statutes and Chapter Trans. 101 thru 305 of the Wisconsin Administrative Code, describing and defining regulations with respect to vehicles and traffic, are hereby adopted and by reference made a part of this Chapter as if fully set forth herein. Any act required to be performed or prohibited by any regulation incorporated herein by reference is required or prohibited by this Chapter. Any future amendments, revisions or modifications of the statutory regulations in Chapters 340 to 349 incorporated herein are intended to be made part of this Chapter in order to secure to the extent legally practicable uniform statewide regulation of vehicle traffic on the highways of the State of Wisconsin. Any person who shall, within the Town of Rome, violate any provisions of any Statute incorporated herein by reference shall be deemed guilty of an offense under this Section.

(b) Other State Laws Adopted: There are also hereby adopted by reference the following sections of the Wisconsin Statutes, but the prosecution of such offenses under this Chapter shall be limited to a forfeiture as hereinafter provided in this Chapter:

1. 941.01 Negligent Operation of Vehicle Off Highway
2. 943.23 Operating Motor Vehicles Without Owners Consent

(2) OFFICIAL TRAFFIC SIGNS AND CONTROL DEVICES; PROHIBITED SIGNS, SIGNALS AND MARKERS:

(a) Erection and Install Uniform Traffic Control Devices: Whenever traffic regulations created by this Chapter, including a State of Wisconsin traffic regulation adopted by reference in par. (a) require the erection of traffic control devices for enforcement the Superintendent of Highways and Public Works shall procure, erect and maintain uniform traffic control devices conforming to the Uniform Traffic Control Device Manual promulgated by the Wisconsin Department of Transportation, giving notice of such traffic regulation to the users of the highways on which such regulations apply. Whenever State law grants discretion to local authorities in erecting or placement of a uniform traffic control device, devices shall be erected in such locations and in such a manner as, in the judgment of the Superintendent or a designee, will carry out the purposes of this Chapter and give adequate warning to users of the highways of the Town of Rome.

(b) Prohibited Signs and Markers in Roadways: No person other than an officer or designee authorized by this Ordinance to erect and maintain official traffic control devices shall place

within the limits of any highway maintained by the Town any sign, signal, marker, mark or monument unless permission is first obtained from the Chief of Police, the Superintendent of Highways and Public Works or, where applicable, the Wisconsin Department of Transportation (DOT).

(c) **Removal of Unofficial Signs, Markers, Signals and Traffic Control Devices:** The Chief of Police, Superintendent of Highways and Public Works or their designee may remove any sign, signal, marking or other device, which is placed, maintained or displayed in violation of this Chapter or state law.

(3) **SCHOOL BUS WARNING LIGHTS:** Notwithstanding the provisions of Sec. 346.48(2)(b) 2., Wis. Stats., school bus operators shall use flashing red warning lights in residential and business districts when pupils or other authorized passengers are to be loaded or unloaded at locations at which there are no crosswalk or traffic signals so that pupils must cross the road before being loaded or after being unloaded.

(4) **SPEED LIMITS:**

(a) Except as modified in par.(b), the speed limits set forth in sec. 346.57-59 Wis. Stats. shall apply.

(b) Pursuant to sec. 349.11 Wis. Stats., the speed limits on certain town highways shall be modified as set forth in Appendix A. The Town Board finds that such modifications are reasonable and safe based on engineering and traffic investigations previously performed. Signs giving notice of the modified speed limits shall be erected consistent with sec. 346.57(6) or 349.11 Wis. Stats. See Appendix A, which is incorporated herein by reference.

(5) **CONTROLLED INTERSECTIONS DESIGNATED:**

(a) **Designation of Location of Stop/Yield Signs:** In the interest of public safety, stop/yield signs shall be installed at locations to control highways over which the Town has exclusive jurisdiction. See Appendix B, which is incorporated herein by reference.

(6) **ONE-WAY STREETS:** Pursuant to section 349.10, Wis. Stats., the following streets and roadways and parts thereof are declared to be one-way streets and no person shall operate any vehicle thereon except in the indicated direction.

(a) Streets:

1. Easterly on Climbers Pass, from Matterhorn Trail to Geneva Trail
2. Westerly on Snow Pass, from Geneva Trail to Matterhorn Trail

(7) WEIGHT LIMITS:

(a) Heavy Traffic Routes

1. Pursuant to sec. 349.17, Wis. Stats., the following Town highways are designated as heavy traffic routes.

Alpine Dr.: STR 13 to CTR Z

Apache Ave.: STR 13 to CTR Z

2. Appropriate signs shall be erected giving notice that said Town highways are heavy traffic routes.

(b) Class B Highways:

1. The following Town highways are designated as Class B Highways subject to the weight limitations set forth in section 348.16, Wis. Stats.:

Akron Dr.: 7th Dr. to STR 13

7th Dr.: STR 73 to Akron Dr.

2. The Superintendent of Highways and Public Works is authorized to issue permits for exceeding such weight limitation.

(c) Heavy Traffic Prohibited:

Pursuant to sec. 349.17, Wis. Stats., all vehicles operating completely on pneumatic tires and all vehicles or combination of vehicles, other than motor buses, designed or used for transporting property of any nature and having a gross weight of more than 6,000 pounds, shall not be operated on any Town highway not listed in paragraph (a) of this section. This paragraph shall not apply to heavy traffic using a Town highway for the purpose of obtaining orders for supplies or moving or delivering supplies or commodities to or from any place of business or residence which has an entrance on such a Town highway, provided such traffic does not exceed the weight limitations for Class B highways pursuant to sec. 348.16, Wis. Stats.

(d) Weight Limits for 8th Avenue Bridge:

The bridge on 8th Avenue located 1 mile south of County Road D or ½ mile north of Apache Avenue over Fourteen Mile Creek shall have a weight limit of the following:

2 axle vehicle	19 tons
3 or more axle vehicles	28 tons
Combination vehicles	37 tons

(e) Special/Seasonal Weight Limitations: The Superintendent of Highways and Public Works shall exercise the authority to set seasonal and special weight limitations pursuant to sec. 349.16 Wis. Stats.

(f) Town Highways Defined: As used in this section, the term “Town Highways” means all highways within the Town of Rome that are maintained and controlled by the Town.

(g) Liability: Pursuant to sec. 86.02 Wis. Stats., any person who shall injure any Town highway shall be liable in treble damages.

(8) RESTRICTIONS ON PARKING; POSTED LIMITATIONS:

(a) No Parking Zones: The following areas are designated as “No Parking Zones”. Parking in such areas shall be permitted only upon permission from a member of the Rome Police Department.

1. Kings Way dam;

2. 15th Avenue dam including the fire department fill site

3. On the paved portion of any town highway between the hours of 12:00am and 6:00am.

(b) Private Property: No person may park any vehicle on private property unless permission has been granted by the owner or occupant of the property.

(c) Seventy-two (72) Hour Limitation: No person, firm or corporation shall park or leave standing any motor vehicle, recreational vehicle, trailer, semi-trailer, appliance, manufactured home or vehicle of any description on any town highway right-of-way, public property or public parking lot in the Town for a period of seventy-two (72) or more consecutive hours in the same location except that where more restrictive parking limits have been established the more restrictive limits shall apply.

(d) Removal of Illegally-Parked Vehicles:

1. When any law enforcement officer shall find a vehicle standing upon a road, public property or public parking lot in violation of the provisions of this subsection, the officer is authorized to move such a vehicle or to require the operator in charge thereof to move such vehicle to a position permitted under this subsection. The officer may cause said vehicle to be removed to a proper impoundment and storage area where storage space is available and in such case the owner shall pay the costs of removing said vehicle and the storage fees on said vehicle before he may recover the possession thereof.

2. Effective July 1, 2014, sec. 349.13 (3m) Wis. Stats. shall also apply to vehicles parked on private property without authorization. If involved in or contacted regarding the removal

process, the police department shall request the collection and payment by the towing service of the maximum service fee referenced in sec. 349.13(3m)(dm).

(e) Abandoned vehicles:

1. As provided for in sec. 342.40(1m) Wis. Stats., any vehicle left unattended for more than 72 hours on any public street or grounds, or on private property without permission of the owner or lessee, is deemed abandoned and constitutes a public nuisance.

2. Any vehicle found abandoned in violation of this ordinance may be impounded by the Town of Rome Police Department until lawfully claimed or disposed of pursuant to sec. 342.40(3)(c) Wis. Stats.

3. The minimum period of storage of a vehicle deemed abandoned pursuant to this section shall be ten (10) days after notice has been sent by certified mail to the owner and lien holders of record regarding the right to reclaim the vehicle.

4. Sale of an abandoned vehicle shall be by sealed bid. As an alternative, the Police Chief in his or her discretion may arrange for the sale of an abandoned vehicle by auction.

5. The purchaser of any vehicle on sealed bid held pursuant to statute shall have ten (10) days to remove the vehicle from the storage area upon payment of storage fee. If not paid within ten days after the sale, the purchaser shall forfeit all interests in the vehicle and the vehicle shall be deemed abandoned and may be sold again.

6. Within five (5) days after sale or disposition of a vehicle under this section, the Clerk shall advise the DOT of such sale or disposition on a form supplied by the DOT.

(f) Vehicles Not to Block Private Drive or Fire Lane: No vehicle shall, at any time, be parked so as to unreasonably restrict the normal access to any private drive or fire lane. Said access shall be deemed to be unreasonably restricted if any vehicle is parked within four (4) feet of either side of said access. Upon discovery by a police officer or upon complaint by the owner of any such blocked drive or fire lane, the police officer may order said vehicle towed from such position at the risk and expense of the owner of said vehicle.

(g) Parking Vehicle for Repair or to Display for Sale Prohibited: No person shall stand or park a vehicle on any highway, right-of-way or municipal parking lot in the Town for the purpose of repairing said vehicle or to display such vehicle for sale.

(h) Posted Limitations:

1. The Town Board may designate certain highways or portions of highways as no parking or no stopping or standing zones or as zones for parking by physically handicapped persons and may limit the hours in which the restrictions apply. The Town shall mark, by appropriate signs, each zone so designated in accordance with the provisions of Sec. 349.13, Wis. Stats.

2. The Chief of Police is hereby granted the authority, within the reasonable exercise of police power, to prohibit, limit the time or otherwise restrict the stopping, standing or parking of vehicles beyond the provisions of Chapter 346.

(i) Enforcement:

1. Persons cited for violation of non-moving traffic offenses described and defined in this section may discharge the penalties thereof and avoid court prosecution by forwarding, within ten (10) days of the issuance of the citation, to the Town of Rome Police Department the penalty specified in the citation. If not timely paid, the citation shall provide that the penalty may be discharged by forwarding the amount indicated on the citation plus an additional late charge as per the bond schedule within twenty (20) days of issuance.

2. If the alleged violator does not deliver or mail a deposit as provided in sub. par. 1. within twenty (20) days from the date of the citation, the police department may proceed under sec. 345.28(3)-(5) Wis. Stats.

3. All officers receiving deposits for non-moving traffic violations under this subsection shall pay over such deposit to the town treasurer within seven (7) days of receipt. Such payment shall be accompanied by an itemized statement for each deposit of the offense charged and the name of the depositor.

(9) UNATTENDED MOTORIZED MACHINERY: It shall be unlawful for any person, firm or corporation to permit any construction, compaction, earth-grading or farm machinery which is self-propelled and moves upon the surface of the earth and which is owned or controlled by him to stand for any period of time unattended without locking the ignition system or otherwise rendering said machinery inoperable so as to prevent any person unauthorized by the owner or individual in control thereof from starting said machinery.

(10) SNOW EMERGENCIES:

(a) Snow Emergency Declarations. A snow emergency exists in the Town whenever a snowfall during any period of twenty-four (24) hours or less reaches a depth of three (3) inches or more. Such emergency is declared to be a serious public hazard impairing transportation and public health, safety, and welfare for a period until such time as snow removal operations have been completed.

(b) During snow emergencies, parking of vehicles, trailers, snowmobiles, ATV's, etc. on the pavement or shoulder of any town road is prohibited until the highway department has plowed the road.

(c) The Public Works Superintendent shall have the authority to declare a snow emergency.

(11) COMPRESSION BRAKES: The use of compression brakes, commonly referred to as “Jake Brakes”, on any motor, shall be prohibited within the Town of Rome except in an emergency situation. Signs that read “No engine braking except in emergency” and comply with WIS DOT R10-64 shall be erected near the northern and southern limits of the Town along State Highway 13.

8.02 BICYCLES:

(1) RULES OF THE ROAD: The provisions of Chs. 346 and 347, Wis. Stats. and applicable Town Ordinances shall govern the operation of bicycles where appropriate.

(2) LIGHTING AND OTHER EQUIPMENT: No person shall operate a bicycle upon a highway unless equipped as required in Sec. 347.489, Wis. Stats.

(3) BICYCLE REGULATIONS:

Bicycles Not to be Pulled by Moving Vehicles: No person riding upon a bicycle shall cling or attach himself or his bicycle to any other moving vehicle upon a highway, nor shall the operator of any such bicycle tow or draw any coaster wagon, sled, person on roller skates, toy vehicles or any other similar vehicle on such highway.

(4) PLAY VEHICLES:

(a) Play Vehicle Areas Prohibited: No person shall operate or make use of a play vehicle on any public parking lot, upon any private parking lot held out for public use or upon any private driveway or private property without the owner's consent.

(b) Responsibility of Parent or Guardian for Violation of Play Vehicle Regulations: No parent or guardian of any child shall authorize or knowingly permit such child to violate any of the provisions of this Section.

8.03 SNOWMOBILES:

(1) STATE SNOWMOBILE LAWS ADOPTED: Except as otherwise specifically provided in this Chapter, the statutory provisions describing and defining regulations with respect to snowmobiles in the following portions of the Wisconsin Statutes are hereby adopted by reference and made part of this Chapter as if fully set forth herein. Acts required to be performed or prohibited by such statutes are required or prohibited by this Chapter. Any future amendments, revisions or modifications of the Statutes incorporated herein by reference are intended to be made part of this Code.

346.02(10) Applicability to Snowmobiles

(2) UNATTENDED VEHICLES: No person shall leave or allow a snowmobile owned or operated by him to remain unattended on any public highway or public property while the motor is running or with the starting key left in the ignition.

(b) The Superintendent of Highways and Public Works is directed and authorized to procure, erect and maintain appropriate snowmobile route, trail and limit signs and markers as approved by the State Department of Natural Resources under Sec. 350.13, Wis. Stats.

(c) Except as provided in Sections 350.02, 350.03 and 350.045 of the Wisconsin Statutes, or for snowmobile events authorized in accordance with Sec. 350.04, Wis. Stats. no person shall operate a snowmobile upon any public right-of-way, in any public park, cemetery or the Rome Transfer Site, except upon snowmobile routes designated by the Town Board.

(5) Prohibited Use of Snowmobile Trails: Except for emergency and law enforcement vehicles, and as provided in Subsection 8.03(1) above, no person shall operate any motor vehicle other than a snowmobile on a snowmobile trail.

8.04 ALL-TERRAIN VEHICLES:

(1) STATE ALL-TERRAIN VEHICLE LAWS ADOPTED: The provisions describing and defining regulations with respect to all-terrain vehicles in Secs. 23.33 and 346.02 (1), Wis. Stats. and any future amendments or revisions, are hereby adopted by reference and made part of this Section as if fully set forth herein.

(2) DESIGNATION OF ALL-TERRAIN ROUTES:

(a) Purpose: To establish all-terrain vehicle routes and provide safe enjoyable all-terrain vehicle recreation consistent with public rights and interest.

(b) Authority: This ordinance is adopted pursuant to the authority given to Towns under sections 23.33(4)(d), 23.33(8)(b) and 23.33(11) Wis. Stats.

(c) Signing: The authorized all-terrain vehicle routes shall be designated by an all-terrain vehicle route sign having a reflectorized white all-terrain vehicle symbol, bordered and message on a reflectorized green background with a minimum size of 24 inches by 18 inches with directional arrow, where appropriate, placed at the beginning of an all-terrain vehicle route and at such locations and intervals as necessary to enable the all-terrain vehicle operators to follow the route.

(d) Operation: All-terrain vehicles shall only be operated on the traveled portions of designated routes and access-only routes.

(e) Access-only Routes:

1. Landowners and their guests may operate all-terrain vehicles on Town highways that are not Designated Routes provided such operation is for the sole purpose of traveling between the Landowner's property and a Designated Route. Further, such operation must follow the shortest and most direct route for traveling between the Landowner's property and the Designated Route.

2. In this section, "Town highway" shall mean any road maintained by and under the jurisdiction of the Town of Rome.

8.05 ABANDONED VEHICLES AND APPLIANCES:

(1) ABANDONMENT: No person shall leave unattended any motor vehicle, recreational vehicle, trailer, semi-trailer, appliance or manufactured home on any road or public property in the Town of Rome for such time and under such circumstances as to cause the vehicle to reasonably appear to have been abandoned. Whenever any such item has been left unattended on any road in the Town of Rome or upon private or public property without the permission of the property owner or person charged with the lawful jurisdiction thereof for more than seventy-two (72) hours it shall be deemed abandoned and constitute a public nuisance.

(2) REMOVAL AND IMPOUNDMENT: Any police officer that discovers any motor vehicle, recreational vehicle, trailer, semi-trailer, appliance or manufactured home on any road or public property in the Town of Rome, which has been abandoned, may cause the vehicle to be removed to a suitable place of impoundment.

8.06 GOLF CARTS:

(1) DEFINITION: The definition of golf cart set forth in sec. 23.33 (1) (fm) Wis. Stats. shall apply to this Section.

(2) OPERATION ON TOWN HIGHWAYS: Subject to sub.(3) herein, a golf cart may be operated on any town highway which has a speed limit of 25 MPH or less. A golf cart may not be operated on any state highway or county highway, regardless of speed limit, or any town highway that has a speed limit higher than 25 MPH.

(3) RULES OF OPERATION: The operation of a golf cart on a town highway pursuant to sub. 2) herein shall be subject to the following requirements:

(a) The operator must be at least sixteen (16) years of age.

(b) The golf cart shall be operated with illuminated headlights and taillights if in operation during hours of darkness as that term is defined in section 340.01 (23) Wis. Stats.

(c) The golf cart shall be operated as close as practicable to the right-hand edge of the paved roadway, except when preparing for a left turn.

(d) The golf cart shall display a slow-moving vehicle sign pursuant to sec. 347.245 (1) and (2) Wis. Stats.

(e) The golf cart shall be operated in a safe manner and in conformance with the rules of the road.

(4) HIGHWAY CROSSING POINTS:

(a) A golf cart operated on a town highway pursuant to sub. (2) herein may not cross another highway except as follows:

- 1.** The highway being crossed is a town highway with a speed limit of 25 MPH or less; or,
- 2.** The highway being crossed is a highway listed in Appendix C, which is incorporated herein by reference.

(b) The golf cart shall stop and yield the right-of-way to all vehicles approaching on the highway before crossing the highway.

(c) Signs approved by the DOT shall be erected by the Town to mark the crossing point on both sides of each highway listed in Appendix C.
