During the month of February, I attended Drug Free Adams County, and Police and Fire Commission meetings. Members of the Adams Police Department, Adams County Sheriff's Office, and myself were given a demonstration on how Waushara County is using Spillman.

Calls for Service

During the month of February, officers handled 105 calls for service, and issued 22 citations and 3 written warnings.

Department Activities/Announcements

Officer Wilson has met with the Wisconsin Department of Natural Resources (WDNR) and completed a boat patrol audit with WDNR staff. A report will be sent in the near future with the results of our audit. The WDNR will reimburse the town for approximately 70% of the approved audit boat patrol expenses. We usually receive this reimbursement in April or May.

The Department has one member off on FMLA leave, the Officer is not expected to return until April 15, 2019.

The Department took delivery of the speed trailer. We continue to seek donations to offset operational costs. Once the snow banks are gone we will start placing the unit in locations that have speeding problems.
