During the month of March, I attended Adams County Highway Committee, Town Board, staff, Criminal Justice Advisory, Drug Free Adams County, and North Central Chiefs of Police Association meetings. Calls for Service

During the month of March, Officers handled 67 calls for service, issued 16 citations, and 9 written warnings.

Department Activities/Announcements

The Department has one member off on FMLA leave, the Officer is not expected to return until April 15, 2019.

We are waiting for the ground to dry out, and snowbanks to melt before using the speed trailer. The unit will be placed in areas that have speeding problems. We hope to have the unit out by the middle of April weather dependent. We continue to seek donations to offset operational costs. The unit will be placed in areas that have speeding problems.

Once the ice is out, we will be setting the regulatory buoys for the 2018 boating season on the lakes.

We received the Water Safety Patrol Reimbursement, from the DNR, in the amount of \$ 11,410.73. We submitted a claim of \$ 15,211.01. The rate of reimbursement in 2018, based on the claims submitted, was 75%.

I will be posting for the 2 open recreational Officer positions in the upcoming weeks. The Officers hired will start on Memorial Day Weekend, and work seasonally through Labor Day weekend.
