April 2019

Meetings/Training Attended

During the month of April, I attended Adams County Board, Town Board, sensitive crimes, Wisconsin Spillman User Group, and strategic planning meetings. Officers Stashek and Anderson attended death investigation training.

Calls for Service

During the month of March, Officers handled 113 calls for service, issued 13 citations, and 4 written warnings.

Department Activities/Announcements

I am working on filling 3 open recreational Officer positions. I have posted the openings on the law enforcement job search web site and only received 2 applications. The position has been reposted and two more applications have come in so far. The Officers hired will start on Memorial Day Weekend, and work seasonally through Labor Day weekend.

I was notified by the Wisconsin Department of Transportation, that we have received another \$ 4,000 equipment grant, for participation in unfunded traffic mobilizations such as click it or ticket.

Again, I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Vehicle Fleet/Maintenance

Squad 80 had a turbo unit fail and is out of service for repairs. The repairs are covered 100% by factory warranty on the unit. The unit had been returned and the turbo failed again before the squad made it back to town.

Squad 83 had a turbo fail and is out of service. I was informed by the Ford repair center that the repair parts have been pulled and it is unknown when parts for repair will be available. I will be working the Ford to see what can be done about this issue.
