## Rome Police Department Monthly Report May 2019

### **Meetings/Training Attended**

During the month of May I attended PFC, sensitive crimes, construction, and strategic planning meetings. Officer Czys completed instructor development training. All the Officers completed firearms qualification.

### **Calls for Service, Citations, and Written Warnings**

In May officers handled 132 calls for service, and issued 21 citations and 9 written warnings.

### **Department Activities/Announcements**

Regulatory buoys have been placed in lakes Camelot and Sherwood for the 2019 boating season.

Boat patrol staff is in place for the 2019 boat patrol season. We have six officers on the roster for the 2019 boating season. The officers will work Friday thru Sunday as the weather warrants for boating enforcement on our local lakes.

The Boat Patrol logged 18 hours of patrol in May and issued 8 citations for various boating law violations. I would remind boaters to ensure they have read the current boating law pamphlet and are following it prior to hitting the water this summer. The regulations are in place to ensure everyone's safety on our lakes.

Officers participated in the national Click-It-Or-Ticket campaign from May 20th – June 2nd. While we did not receive any additional funding this year to add additional patrols, officers focused on traffic enforcement at various times throughout their scheduled shifts. By participating in this campaign the police department becomes eligible to receive grant funding for equipment in a lottery held by WI DOT later in the year. We are pleased to announce we had a safe Memorial Day weekend with no traffic fatalities or major incidents.

For our participation in WI DOT campaigns in 2018-2019 we were awarded a second \$ 4,000 equipment grant. The funds will be used to purchase a Panasonic Arbitrator Camera System for the squad car that will be ordered later this year.

Two of the Ford Utility squads have been repaired by Ford and have been back in service without issues.
