## Rome Police Department Monthly Report June 2019

### **Meetings/Training Attended**

During the month of June I attended PFC, Drug Free Adams County, Town Board, construction, North Central Chiefs of Police Association, and Spillman meetings.

### **Calls for Service, Citations, and Written Warnings**

In June officers handled 145 calls for service, and issued 53 citations and 16 written warnings.

### **Department Activities/Announcements**

The Boat Patrol logged 78.5 hours of patrol in June and issued 20 citations for various boating law violations. I would remind boaters to ensure they have read the current boating law pamphlet and are following it prior to hitting the water this summer. The regulations are in place to ensure everyone's safety on our lakes.

We have been receiving complaints of boat traffic and water skiing after 8:00 pm on Lakes Camelot, Sherwood, and Arrowhead. As a reminder these lakes are all slow no wake after 8:00 pm. If residents observe boating violations on a routine basis in a particular area we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

I would like to continue to remind residents the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.
