During the month of September, I attended budget, Spillman, staff, and building meetings.

Calls for Service, Citations, and Written Warnings

In September officers handled 134 calls for service, issued 76 citations, and 61 written warnings.

Department Activities/Announcements

This is the time of year, we would like to remind our residents that if they are planning to leave their home, for an extended period of time, please stop by the Police Department, or visit us online first. We have forms so you can provide us with your contact information should there be an emergency at your property.

The boat patrol has completed their duties for the 2019 boating season. We are now working to complete the final boat patrol enforcement totals, and will be submitting those figures to the DNR. They will provide reimbursement for a portion of our boat patrol expenditures. The regulatory buoys have been removed from Lake Sherwood and Camelot for the winter.

Officer Valiquette will be leaving the Department to join the Wood County Sheriff's Department. His last day of work will be October 3, 2019. We wish him good luck in his future endeavors. Part time Officers will be utilized to cover the vacancy left by his departure.

The Police operations have moved to the new Police/EMS building located by the south driveway of the Town Hall property. I anticipate the move will be complete by the second week of October.

Office hours at the new Police/EMS building are Monday thru Thursday 8am thru 12pm. Outside these hours the building is locked and requires an appointment for services. Also, these are the only hours the drug drop box will be available moving forward. Citizens needing non-emergency assistance outside these office hours should call the dispatch center at 877-885-9977. As always for emergencies call 911.
