### **Meetings/Training Attended**

During the month of October, Officer Wilson attended an evidence management training, Sgt. Anderson attended interview and interrogation training. I attended a meeting on the Spillman records system.

### **Calls for Service, Citations, and Written Warnings**

In October officers handled 136 calls for service, issued 42 citations, and 24 written warnings.

### **Department Activities/Announcements**

Once again, it is the time of year, we would like to remind our residents that if they are planning to leave their home, for an extended period of time, please stop by the Police Department, or visit us online first. We have forms so you can provide us with your contact information should there be an emergency at your property.

The Police Department held a drug take back event in October and 9 pounds of medication was collected. A total of 38 pounds was collected since the Spring 2019 takeback event. The take back box is located in the P.D. Hours the drop box can be utilized are Monday thru Thursday 8am thru 12pm.

The police department participated in the Children's Halloween Party at the Town Hall. We operated our child ID card system and help produce about 30 child ID cards.

As a reminder, office hours at the new Police/EMS building are Monday thru Thursday 8am thru 12pm. Outside these hours the building is locked and requires an appointment for services. Also, these are the only hours the drug drop box will be available moving forward. Citizens needing non-emergency assistance outside these office hours should call the dispatch center at 877-885-9977. As always for emergencies call 911.
