## Rome Police Department Monthly Report December 2019

### **Meetings/Training Attended**

During the month of December, Sergeant Anderson, Officer Wilson, and I completed an EMR refresher course online. I attended Spillman Steering Committee and Child Death Review meetings.

### **Calls for Service, Citations, and Written Warnings**

Officers handled 90 calls for service, issued 49 citations and 8 written warnings.

### **Department Activities/Announcements**

The Rome Police Department ended 2019 with a total of 1,479 calls for service. This is an increase of 6.4% over 2018. In 2019 the Department issued 490 citations, that number includes traffic, municipal, and boating citations; 216 written warnings were issued throughout the year as well.

With warm weather in the forecast, I would remind residents to be aware of changing ice conditions on the area lakes before traveling out on the ice. In the past we have had vehicles go through the ice on the lakes.

If you are leaving town over the winter months, please stop by the police department or go to our web site and complete a vacant home form. Should residents see something out of the ordinary with vacant properties please report them to the police department immediately.
