Rome Police Department Monthly Report February 2020

Meetings/Training Attended

During the month of February, I attended Spillman, Adult Community Crisis, Roche A Cri Consortia, and Department Head meetings. Sergeant Anderson and Officer Czys attended CPR Instructors Course, Officer Goodness attended CPR refresher. Officer Wilson and Ryan Arnett (Police Administrative Assistant/Municipal Court Clerk) attended records retention training. Full Time Officers also attended the Adams County Sheriff's Office Inservice training.

Calls for Service, Citations, and Written Warnings

During the month of February officers handled 93 calls for service, issued 32 citations, and 17 written warnings.

Department Activities/Announcements

The Department received a \$300.00 donation from Lake Arrowhead Association that was raised during the 2020 SnoBlast event.

January and February have been busy months for the police department. Officers continue to investigate several felony burglary and theft cases that arrests were made on in the fall of 2019.

I will be working in March to establish the 2020 boat patrol roster. Since we will hopefully be at full staff by this summer, I intend to also utilize our fulltime officers in patrolling our lakes and ATV trails. This should not only increase the amount of patrol on our lakes, but will also increase our DNR reimbursement, due to the fulltime officer's wage being higher than part-time officers. Sergeant Anderson will have to attend mandatory training for the boat patrol this spring, so we remain eligible to submit costs to the DNR for reimbursement.

Routine maintenance was done to the fleet during February.
