Rome Police Department Monthly Report June 2020

Meetings/Training Attended

During the month of June, I attended Spillman, Town Board, Police and Fire Commission, North Central Chief of Police, and COVID-19 Webinar meetings. The Rome Police Department Participated in a mock ATV/UTV crash scenario put on by the Adams County Sheriff's Office.

Calls for Service, Citations, and Written Warnings

During the month of June officers handled 147 calls for service, issued 23 citations, and 3 written warnings. The Boat Patrol logged 65 hours of patrol and issued 7 citations and 10 warnings.

Department Activities/Announcements

We have been receiving complaints of boat traffic and water skiing after 8:00 pm on Lakes Camelot, Sherwood, and Arrowhead. As a reminder these lakes are all slow no wake after 8:00 pm. If residents observe boating violations on a routine basis in a particular area we urge them to call the Rome Police Department so we can give these problem areas some extra attention. The Rome Police Department will have a zero tolerance for violations of after 8:00 pm boating laws. If you are caught by an officer violating these ordinances you can expect a citation.

As a reminder, ATV/UTV traffic is prohibited from traveling on STH 13 and most of CTH Z except to directly cross when on an ATV/UTV route or trail. Also, anyone under 18 years old is required to have a DOT approved helmet on. Bicycle helmets do not meet this requirement. Lights are required to be on at all times while on routes and trails. Please read up on ATV/UTV laws before hitting the routes and trails.

I would like to continue to remind residents the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Squad 83 was involved in a car deer crash and remains out of service for repairs.
