Rome Police Department Monthly Report July 2020

Meetings/Training Attended

During the month of July, I attended Spillman, Town Board, and COVID-19 Webinar meetings.

Each year the State of Wisconsin requires every police officer to attend at least 24 hours of training to maintain their certification as a law enforcement officer. The fiscal year for this requirement ended on June 30th. I would like to report that all officers in the Rome Police Department met this requirement by exceeding 24 hours of professional development. I have submitted the training compliance report to the Wisconsin Training and Standards Bureau. T&S will reimburse the Town of Rome for each officer that completed the minimum 24-hours of training.

Calls for Service, Citations, and Written Warnings

During the month of July officers handled 199 calls for service, issued 31 citations, and 23 written warnings. The Boat Patrol logged 160 hours of patrol and issued 25 citations and 30 warnings.

Department Activities/Announcements

We continue to receiving complaints of boat traffic and water skiing after 8:00 pm on Lakes Camelot, Sherwood, and Arrowhead even after several citations being issued for these violations. As a reminder these lakes are all slow no wake after 8:00 pm. If residents observe boating violations on a routine basis in a particular area we urge them to call the Rome Police Department so we can give these problem areas some extra attention. The Rome Police Department will have a zero tolerance for violations of after 8:00 pm boating laws. If you are caught by an officer violating these ordinances you can expect a citation.

As a reminder, ATV/UTV traffic is prohibited from traveling on STH 13 and most of CTH Z except to directly cross when on an ATV/UTV route or trail. Several riders have been cited for this violation and ATV/UTV traffic is continuing to be a problem on STH 13.

Squad 80 and 85 were damaged in separate incidents while parked at Officers homes. Repairs have been made to both units and the Officers issued the cars were required to pay the Town for the damages to each vehicle.
