Rome Police Department Monthly Report September 2020

Meetings/Training Attended

During the month of September, I attended Covid-19, Lexipol Policy, North Central Chiefs of Police Association, Spillman, staff, and board meetings.

Calls for Service, Citations, and Written Warnings

In September officers handled 167 calls for service, an increase of 21.9 % over 2019, issued 44 citations, and 11 written warnings. The Boat Patrol logged 21 hours of patrol, issued 1 citation.

Department Activities/Announcements

This is the time of year, we would like to remind our residents that if they are planning to leave their home, for an extended period of time, please stop by the Police Department, or visit us online first. We have forms so you can provide us with your contact information should there be an emergency at your property.

The boat patrol has completed their duties for the 2020 boating season. We are now working to complete the final boat patrol enforcement totals, and will be submitting those figures to the DNR. They will provide reimbursement for a portion of our boat patrol expenditures.

Regulatory markers will be removed from the lakes during the upcoming weeks. The patrol boats will be scheduled for winterization soon.

The Police Department 2021 budget has been completed and submitted to the Administrator.

Squad 80 was returned, from Rapids Ford, after being out of service for a month with engine problems. The part was not readily available due to COVID-19. The work was all warranty repairs at no cost to the Town.

I continue to work on implementation of the new policy book for the police department. The roll out will be complete by the end of the year.
