During the month of October, I attended Covid-19, Lexipol Policy, North Central Chiefs of Police Association, Spillman, and board meetings. I also attended the virtual Spillman, and Badger TraCS user conferences.

Calls for Service, Citations, and Written Warnings

In October officers handled 128 calls for service, issued 22 citations, and 3 written warnings.

Department Activities/Announcements

I would like to remind Rome residents that per Town Code 335-10 “a snow emergency exists whenever a snowfall results in an accumulation of 3 inches or greater within a 24-hour period.” During a snow emergency the parking of any vehicle on any portion of the roadway is prohibited. In the interest of public safety please make sure you keep the roadways clear of obstructions for our highway workers.

Once again, I would like to remind our residents that if they are planning to leave their home, for an extended period of time, please stop by the Police Department, or visit us online first. We have forms so you can provide us with your contact information should there be an emergency at your property.

I continue to work on implementation of the new policy book for the police department. The roll out will be complete by the end of the year.
