### **Meetings/Training Attended**

During the month of April, I attended Town Board, Annual, Spillman, staff, and COVID-19 meetings. Officer Jenks continues attending Emergency Medical Responder training.

### **Calls for Service, Citations, and Written Warnings**

During the month of April, officers handled 118 calls for service, issued 10 citations, and 12 written warnings.

### **Department Activities/Announcements**

I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Officer Stashek and I continue working on the upfit of the 2021 Ford Explorer.

### **Vehicle Fleet/Maintenance**

One of the 2017 Ford Explorers is out of service with turbo issues. The repairs are covered under warranty.
