## Rome Police Department Monthly Report May 2021

### **Meetings/Training Attended**

During the month of May, I attended Town Board, and staff, meetings. Officer Jenks completed Emergency Medical Responder training. Officer Stashek attended the CCRT meeting.

### **Calls for Service, Citations, and Written Warnings**

During the month of May, officers handled 153 calls for service, issued 23 citations, and 17 written warnings. The boat patrol logged 60 hours of patrol, issuing 6 citations and 2 written warnings.

### **Department Activities/Announcements**

A reminder to residents and guests that jet skiing and water skiing is prohibited from 8:00pm to 10:00am. Officers will be stringently enforcing the boating laws on the lakes after receiving complaints of violations.

It is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Sergeant Anderson resigned from the police department in May. Officer Spanske will be put into an LTE position in June to fill the open shift. Officer Jasin continues with field training.

Officer Stashek and I work on the upfit of the 2021 Ford Explorer when time allows.

### **Vehicle Fleet/Maintenance**

Routine maintenance was done to the fleet in May.
