Rome Police Department Monthly Report July 2021

Meetings/Training Attended

During the month of July I attended Town Board meetings.

Each year the State of Wisconsin requires every police officer to attend at least 24 hours of training to maintain their certification as a law enforcement officer. The fiscal year for this requirement ended on June 30th. I would like to report that all officers in the Rome Police Department met this requirement by exceeding 24 hours of professional development. I have submitted the training compliance report to the Wisconsin Training and Standards Bureau. T&S will reimburse the Town of Rome for each officer that completed the minimum 24-hours of training.

Calls for Service, Citations, and Written Warnings

In July officers handled 215 calls for service, and issued 38 citations and 11 written warnings. The Boat Patrol logged 111 hours of patrol and issued 11 citations, and 5 written warnings.

Department Activities/Announcements

Over the holiday weekend I observed Fireworks being discharged around the lakes. I would like to continue to remind residents the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

I would like to remind residents and guests that jet skiing and water skiing is prohibited from 8:00pm to 10:00am. We continue to receive complaints of boating violations during slow-no-wake hours. Officers will continue to stringently enforce the boating laws on the lakes.

Routine maintenance was done to the fleet in July.
