### **Meetings/Training Attended**

During the month of August, I attended PFC, staff, and Town Board meetings.

### **Calls for Service, Citations, and Written Warnings**

In August officers handled 173 calls for service, and issued 34 citations and 3 written warnings. The boat patrol logged 111.5 hours of patrol, issuing 5 citations.

### **Department Activities/Announcements**

The boat patrol will conclude their seasonal duties on Labor Day weekend. Final numbers will be totaled and reports completed for the DNR. The patrol program has had another successful year with no serious injuries or fatalities reported on our lakes. I would like to thank the boat patrol officers for all their hard work throughout the summer.

Officers participated in the Adams County Family Night held at the Adams County Fairgrounds in August.

The Police and Fire Commission held interviews for two open full-time officer positions. The commission provided me a list of candidates to fill the open positions from. I will be filling one position in September. The second position has an LTE Officer in place through early December. The position will be filled after the LTE position assignment concludes.

One of the 2017 Ford Interceptors is out of service with turbo and timing chain issues. This repair will be covered under the factory warranty. Routine Maintenance was done to the rest of the fleet during the month of August.
