Meetings/Training Attended

During the month of September, I attended Ambulance District creation joint meetings, Town Budget, Town Board, COVID-19 briefing, and North Central Chiefs of Police Association meetings.

Calls for Service, Citations, and Written Warnings

During the month of September, officers handled 152 calls for service, issued 15 citations and 12 written warnings. The Boat Patrol logged 53.5 hours of patrol, issued 1 citation, and 5 warnings.
