Rome Police Department Monthly Report June 2022

Meetings/Training Attended

During the month of June, I attended a digital search warrant training online. I attending a Town staff meeting and a Spillman meeting.

Calls for Service, Citations, and Written Warnings

During the month of June, officers handled 155 calls for service, issued 74 citations, and 35 written warnings. The Boat Patrol logged 54 hours of patrol and issued 3 citations and 2 warnings.

Department Activities/Announcements

We have been receiving complaints of boat traffic on the lakes. Most complaints are about boats traveling too fast and after hours. State law prohibits traveling faster than slow no wake within 100 feet of any dock raft or pier. State law also prohibits personal watercraft from traveling faster than slow no wake within 200 feet of shore. *In June, the Town Board changed the Town Code that had exempted Lakes Arrowhead, Camelot, and Sherwood from State Law that required Slow No Wake within 100 feet of shore. As a result of this change, motorboats are now restricted to Slow No Wake anytime they travel within 100 feet of the shoreline, on any part of the lakes.* Also, as a reminder Lakes Camelot, Sherwood, and Arrowhead are all slow no wake after 8:00 pm. If residents observe boating violations, on a routine basis, we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

We received several complaints about fireworks and had social media posts about the discharge of fireworks. If you see someone lighting illegal fireworks call the Adams County Dispatch center and report the incident. The Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. **NONE of those sites are in the Town of Rome. Any discharge of fireworks, without a permit issued by the Town of Rome, is illegal. If you are caught you will be issued a citation for illegal discharge the fine is \$250.00, and the fireworks will be confiscated.**

Routine maintenance was done to the fleet during June.
